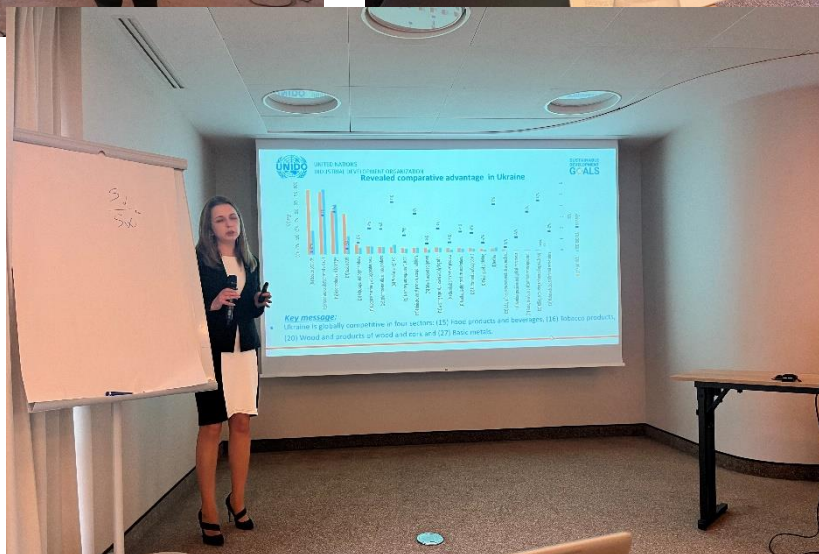

Final workshop on diagnostics and industrial policy

11-14 March 2024 | Serock, Poland

This programme outlines the last workshop under the project “Industrial capacity-building, policy advice and diagnostics for the green recovery of Ukraine”, Output 2: “Industrial policy advice and capacity development”.

The workshop will serve the following objectives:

- a) Presentation of findings from UNIDO’s Ukraine industrial diagnostic study prepared under this project that has been conducted with the collaboration and validation of Ukraine stakeholders;
- b) Enable participants to draw lessons learned from two study trips organized in 2023 on innovation (Germany) and circular economy (Italy) and provide recommendations for the green recovery of Ukraine; and
- c) Continue the dialogue on modalities for further cooperation between Ukraine and UNIDO in regard to industrial policymaking.

Background

The project “Industrial capacity-building, policy advice and diagnostics for the green recovery of Ukraine” is funded by the German Federal Ministry for Economic Cooperation and Development (BMZ) and implemented by the United Nations Industrial Development Organization (UNIDO). It runs from May 2023 until March 2024.

The overall objective of the project is to provide technical support to the Government of Ukraine in conceptualizing and operationalizing a strategic approach towards green industrial reconstruction and development through the coherent, evidence-based and result-oriented green recovery programme for inclusive and sustainable industrial development, which is to be led and owned by the Government of Ukraine.

The project’s Output 2 (Industrial policy advice and capacity development) focuses on building the capacity of relevant Staff in the Ministry to produce a coherent, efficient and evidence-based industrial strategy in the future. In order to exemplify some of the topics covered in training sessions, two study tours – to Italy and Germany – have been organized under this Output.

Participants trained throughout the Output’s activities shall eventually contribute to the country’s policy analysis, gather and create intelligence as inputs to the policy process, perform an advisory function to the Government and be in charge of the monitoring and evaluation function.

The workshop

This workshop is the last of a series of training courses on industrial analytics, strategy setting, and policy design organized for representatives from various Ministries in Ukraine. The four-day workshop will take place in Serock, near Warsaw, Poland.

It covers the following elements.

1. The industrial diagnostics approach
2. Findings from the industrial diagnostics report for Ukraine
3. The DIVE tool
4. Lessons learned from study trips to Germany and Italy
5. Consultations on the way forward



The workshop is fully financed by UNIDO, including travel, accommodation and catering of participants.

The workshop will be conducted in English with translation into Ukrainian.

Speakers' biographies

Nicola Cantore

Research and Industrial Policy Officer, UNIDO



Nicola Cantore is currently a research and industrial policy officer at UNIDO's Division of Capacity Development, Statistics and Industrial Policy Advice. His work includes research, policy advice and capacity building. Prior to this, he worked as a junior researcher at the FEEM (Fondazione ENI Enrico Mattei) in Milan, as a senior researcher at the Department of Agricultural Economics and Engineering of the University of Bologna and as a research fellow at the Overseas Development Institute in London. His research interests include environment, development and structural change.

Mr. Cantore holds a Ph.D in environmental economics and management at the University of York and a Ph.D in economics at the Università Cattolica del Sacro Cuore.

Olha Ilyash

National Consultant, UNIDO



Ms. Olha Ilyash has been working as a National Consultant on Industrial Policy at UNIDO since 2023 and has been consulting with government and business representatives on macro-level Analysis of Ukraine's Inclusive and Sustainable Industrial Performance as part of the preparation of the report "Ukraine: Industrial Diagnostic Study". Currently, she is investigating the value chain diagnostics of electric storage batteries and float glass products.

Previously, she worked as a Senior Research Fellow at the National Institute for Strategic Studies by the President of Ukraine, and prepared 7 analytical notes to the Ministry of Social Policy, the Secretariat of the Committee on National Security and Defense of the Verkhovna Rada of Ukraine in the field of Socio-economic security and Government Regulation.

Ms. Ilyash is a Member of the Sector "Economics" of the Expert Council of the Ministry of Education and Science of Ukraine, European Commission Expert in the Expert area Education, Audio-Visual and Culture Executive Agency of COSME programs (EU Commission) and Expert advisor of reviewing and benchmark of courses according to the AQF standards (New Delhi, India).

Ms. Ilyash holds a Doctor of Science degree, Professor in Economics of the National Technical University of Ukraine "Igor Sikorsky Kyiv Polytechnic Institute" (Ukraine) and a Dr. Habilitowany degree of the Nicolaus Copernicus University (Poland). She is the author of more than 250 scientific works.

Ms. Olha Ilyash is the head of the NGO "Academic Space", which has been functioning as a volunteer hub since the beginning of the full scale invasion of russia to Ukraine.

Davide Vurchio is Assistant Professor of Economics at the Department of Economics and Finance of the University of Bari where he obtained his PhD in 2016. He has been working as research fellow at Roma Tre University and University of Milan and contributed to research projects for UNIDO, FAO, World Bank and Italian research centres such as CRES Rossi-Doria, Ismeri Europa, and Cerpem. His main fields of work are industrial policy, international trade, and development economics.

Ms. Viktoriia Khaustova has been working as a National Industrial Policy Advisor at UNIDO since 2023 under the project 230030 "Industrial Capacity Building, Policy Advisory and Diagnostics for Ukraine's Green Recovery", focusing on "Product analysis to identify key diversification strategies for Ukraine". She is currently involved in the next phase of the project, which focus on value chain diagnostics.

Ms. Khaustova is also the Director of the Research Centre for Industrial Problems of Development of the National Academy of Sciences of Ukraine, which is one of the main institutions of the economic profile of the National Academy of Sciences in the eastern part of Ukraine. Ms. Khaustova has participated in more than 40 scientific and applied research and projects, both as a supervisor and researcher, carried out by the National Academy of Sciences of Ukraine and other universities of Ukraine.

Ms. Khaustova participated in the preparation of a number of strategic documents for public authorities, including: The strategy of socio-economic development of Kharkiv region in 2021-2027, The strategy of socio-economic development of Kharkiv region until 2015, The strategy of development of Kharkiv until 2020, etc.

Since 2023, she has been the scientific advisor of the project "Creation of synthetic liquid fuel production from coal in Ukraine in the war and post-war periods" funded by the National Research Foundation of Ukraine.

Ms. Khaustova holds a Doctor of Economics, Professor, author of about 400 scientific papers in the field of industrial policy, energy development, etc.

Tetiana Salashenko

Ms. Salashenko is a National Consultant in the UNIDO project 230030 "Industrial capacity-building, policy advice and diagnostics for the green recovery of Ukraine".
